Increases of fixed assets due to business operations at acquisition prices (excl. merger increases).

a.1 Basic improvements of tangible assets

On the 'Basic improvements' row are given the activated repair, installation and conversion work that increases the values of fixed assets and whose effect lasts over one year. Basic improvements are valued according to the acquisition cost.

b. Decreases

Decreases due to business operations during the financial year by the value with which the business operations really were conducted, e.g. acquisition price or other payment.

3. Land and water constructions

Land and water constructions refer to streets, roads, railways and tramways, bridges, jetties, dams, basins, water and sewage networks, fuel tanks, energy plants, rock shelters, power and data transmission lines and other such fixed assets.

4. Buildings and structures

Buildings refer to residential buildings and other houses.

5. Machinery and equipment

Machinery, equipment and transport equipment are reported together.

6. Other tangible assets

Other tangible assets include gravel, ore, peat and other natural resources and tangible rights. Shares and holdings are not given here.

Shares and holdings belonging to fixed assets (Non-current assets) in the balance sheet.
